In this Call, projects within the Low-carbon field scope or contributing to clean Energy solutions are welcome.

For this call, you are invited to submit a “Project Outline” (PO), which is the first step of the Eurogia submission process. In this case, the proposal can be simplified, as opposed to the Full Project Proposal (FPP) to be submitted in the second step. The Consortium will have the chance to present the PO at the Eurogia Technical Committee meeting which will happen 2nd half of September, through a 20’ presentation followed by a Question/Answer session, in order to get the recommendations from the experts. The relevant Public Authority representatives are also invited as observers. **[Templates](#)** of the PO document and presentation can be found on the Eurogia website.

Making a project proposal for the upcoming Call is easy, register to the **[Submission Tool](#)**, upload the Project Proposal and indicate the main topical areas you do address.

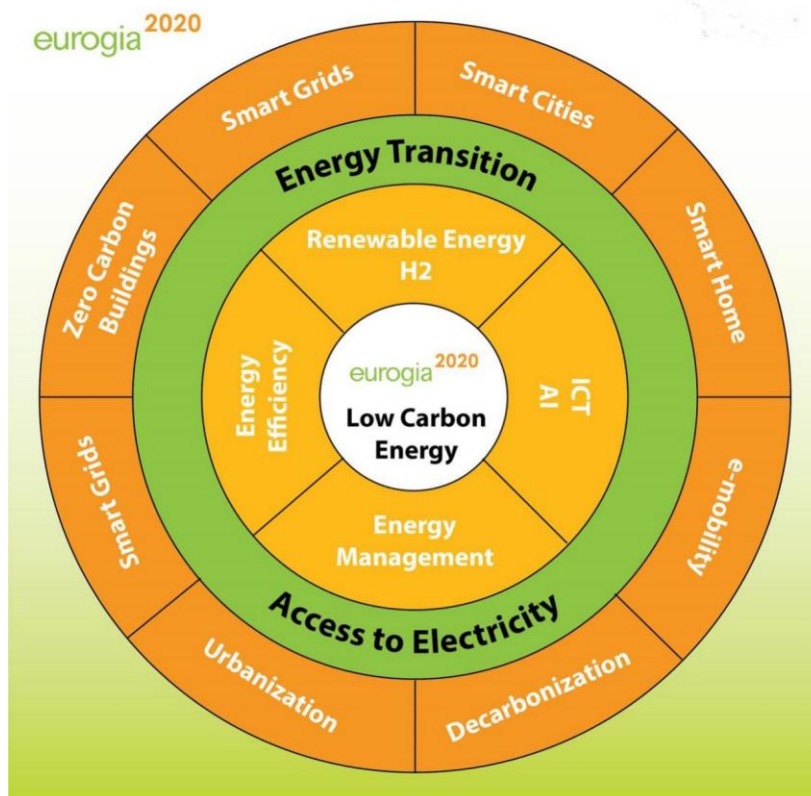
